  - The Clerk reported that the daffodil bulbs had arrived and that she would be working with the team from Sissons Gardening Services on 2<sup>nd</sup> November to get them planted around the Village.
- b) The Clerk updated that the cutting back of the Orchard had been delayed due to wet weather and ground conditions, but that this would be completed as soon as conditions improved.
  - It had been raised with Councillors that some of the trees were becoming choked with weeds Clerk to inspect and report back at the December meeting.
- c) The Clerk reported that the professional tree inspection of the Gilman Trail was scheduled for 12<sup>th</sup> November 2021.
- d) Councillors discussed the Play Area and the Clerk advised that the barrier was scheduled to be installed later in the month.
  - The Clerk reported that the Office of Andrew Percy had made contact regarding the Play Area, as they had been approached regarding providing accessible equipment. The Clerk advised that this query had been passed to the Bonby Playing Field Committee.
